


## The 2019 Early Care and Education Workforce in Durham County

As part of the statewide 2019 North Carolina Early Childhood Workforce Study funded by the Division of Child Development and Early Education, data were collected from Durham County.

This report summarizes key findings from directors, teachers, and assistant teachers who participated from Durham County. Additional findings from family child care providers in urban counties are also presented. In Durham County, a 65% random sample of the licensed centers serving children from birth to five years of age was surveyed. Surveys were returned from a total of 71% of directors (n=64) and 59% of teachers and assistant teachers in those programs. (A total of 345 surveys were returned from the teaching staff.) Detailed information about survey methods and definitions of key terms can be found in the appendix to the 2019 statewide report at childcareservices.org. All of the data for this study were collected prior to the onset of the COVID-19 pandemic. Totals may not equal one hundred percent due to rounding.



138 centers in Durham County provided early care and education to 6,452 • **Programs** birth to five year olds. On average, centers employed 10 teaching staff and had 40 birth to five year olds enrolled. Starting teachers made an average of \$12.00 per hour with a highest average salary of \$15.00 per hour. Starting assistant teachers made an average of \$10.00 per hour with a highest average salary of \$12.50 per hour. **49%** of centers provided fully or partially paid health insurance. • Percentage of centers that provided paid time off: • 81% sick leave 92% vacation leave 95% holiday leave **30%** of centers provided disability, **58%** provided parental leave, and **44%** provided retirement.

Education	<ul> <li>88% of directors and 55% of the center-based teaching staff had at least an associate degree in any field of study. Statewide, 87% of directors and 62% of the teaching staff had at least an associate degree in any field of study.</li> <li>A degree specifically in the early childhood education field provides unique knowledge for those working with young children. In the county, 50% of directors and 31% of the teaching staff had at least an associate degree specifically in the field of early childhood education. Statewide, 50% of directors and 40% of the teaching staff had at least an associate degree specifically in the field.</li> <li>Nearly all directors and center teaching staff had taken at least one college level course in the early childhood education field. Further, 90% of directors and 53% of the teaching staff, had taken six or more courses in early childhood education.</li> </ul>
Experience/ Turnover	<ul> <li>10.0 years: average time directors had been in their programs compared to 6.4 years statewide.</li> <li>2.4 years: average time the center teaching staff had been in their programs compared to 3.8 years statewide.</li> <li>20.0 years: average time directors had been working in the early childhood education field compared to an average 20.0 years statewide.</li> <li>10.0 years: average time the center teaching staff had been working in the early childhood education field compared to 12.0 years statewide.</li> <li>Over the prior 12 months, 21% of the full time teaching staff left their early care and education program. Approximately 30% of the teaching staff plan to leave the field in the next three years. Similarly, 9% of the directors plan to leave the field in the next three years.</li> </ul>
Compensation	<ul> <li>On average, the early care and education teaching staff made \$13.00 per hour and directors made \$19.23 per hour. The statewide average for the center- based teaching staff was \$12.00 per hour. The statewide average director wage was \$19.23 per hour.</li> </ul>



Demographics	<ul> <li>Median director age: 50 years old.</li> <li>Median teaching staff age: 36 years old.</li> <li>95% of directors and 99% of the teaching staff were female (remaining percentage was male, non-binary, or preferred not to answer).</li> <li>69% of directors and 84% of the teaching staff were people of color.</li> <li>2% of directors and 12% of the teaching staff were Hispanic/Latinx/Spanish.</li> <li>29% of the teaching staff had no health insurance from any source.</li> <li>46% of the teaching staff received public assistance in the prior three years.</li> </ul>
Comparing Infant-Toddler and 3-5 Year Old Teaching Staff	<ul> <li>59% of the 3 to 5 year old teaching staff and 50% of the infant-toddler teaching staff had a degree in any field. Statewide, 69% of the 3 to 5 year old teaching staff and 53% of the infant-toddler teaching staff had a degree in any field.</li> <li>The 3 to 5 year old teaching staff averaged 2.6 years in their current program compared to 2.2 years for the infant-toddler teaching staff. Statewide, the 3 to 5 year old teaching staff averaged 4.0 years in their current program compared to 3.1 years for the infant-toddler teaching staff.</li> <li>The 3 to 5 year old teaching staff averaged 11.0 years in the field compared to 10.0 years for the infant-toddler teaching staff.</li> <li>The 3 to 5 year old teaching staff averaged 11.0 years in the field compared to 10.0 years for the infant-toddler teaching staff.</li> <li>The 3 to 5 year old teaching staff made \$14.00 per hour compared to \$12.73 per hour for the infant-toddler teaching staff. Statewide, the 3 to 5 year old teaching staff made \$12.45 per hour compared to \$11.00 per hour for the infant-toddler teaching staff.</li> </ul>





## Family Child Care in Urban\*\* Communities

<b>Programs</b>	<ul> <li>50% provided evening care.</li> <li>23% provided overnight care.</li> <li>22% provided weekend care.</li> <li>13% cared for sick children.</li> <li>16% provided care on legal holidays.</li> <li>74% provided drop-in care.</li> <li>57% accepted children who received subsidy.</li> <li>77% participated in the Child and Adult Care Food Program.</li> </ul>
Education	<ul> <li>51% had at least an associate degree in any field.</li> <li>33% had at least an associate degree in the early childhood education field.</li> <li>Statewide, 51% of family child care providers had a degree in any field and 38% had a degree specifically in the field.</li> <li>71% of urban family child care providers had taken six or more early childhood education courses.</li> </ul>
Experience/ Turnover	<ul> <li>18.0 years: average time running their family child care home compared to 18.0 years statewide.</li> <li>21.0 years: average time working in the early childhood education field compared to 21.5 years statewide.</li> <li>9% of family child care providers in urban communities plan to leave the field in the next three years.</li> </ul>
Compensation	<ul> <li>Family child care providers in urban communities worked 52.5 hours per week and made \$10.48 per hour. The statewide average for family child care providers was \$9.09 per hour.</li> <li>73% required families to pay for days they were sick.</li> <li>76% required families to pay for vacation days.</li> </ul>
Demographics	<ul> <li>99% of family child care providers were female. (Remaining percentage was male, non-binary, or preferred not to answer.)</li> <li>Family child care providers in urban communities averaged 54 years of age.</li> <li>80% of family child care providers were people of color.</li> <li>3% were Hispanic/Latinx/Spanish.</li> <li>13% of family child care providers had no health insurance from any source.</li> </ul>
