



T.E.A.C.H. Early Childhood® Early Care and Education Community Specialist Scholarship Program



What is the purpose of the T.E.A.C.H. Early Childhood® Early Care and Education Community Specialist Scholarship Program?

The T.E.A.C.H. Early Childhood® Early Care and Education Community Specialist Scholarship Program is designed to increase access to relevant early childhood and child development focused coursework by those individuals who are working on behalf of young children in the early care and education system.

Who is eligible to apply for the T.E.A.C.H. Early Childhood® Early Care and Education Community Specialist Scholarship Program?

Individuals may be eligible to apply if they are currently employed with any of the following early care and education organizations:

- Head Start
- Child Care Resource and Referral agencies (CCR&R)
- NC local Smart Start partnerships
- NC Community College early childhood associate degree programs
- Early Intervention programs
- Health Departments (Nurse Educators), or
- Child care program nutritionists
- Division of Child Development and Early Education (DCDEE) must perform function on site with licensed child care facilities

Priority will be given to applicants who make less than \$58,000 annually.

How does the Early Care and Education Community Specialists Scholarship Program work?

Individuals who are awarded the scholarship will receive a stipend for each course taken to offset their educational costs. In return, the scholarship participant is expected to successfully complete their courses and maintain employment while enrolled in coursework.

What function must the individual be performing for the employing organization in order to be eligible?

An individual may be eligible to receive a scholarship if she has been providing home visiting, professional development, coaching, mentoring, technical assistance, health education for child care programs, or monitoring and licensing child care programs for at least 6 months in the employing organization.

What other scholarship eligibility requirements must be met?

In order to be eligible, the individual must

- Be employed at least 30 hours per week at the time of application submission;
- Be eligible for enrollment in either a NC community college early childhood associate degree program or have at least 55 transfer credits into a participating university's bachelor's degree child development program, or have a bachelor's degree in any field and taking course work at the bachelor's/graduate level in Child Development, Early Childhood Education, or Early Childhood Mental Health (graduate level only);
- Provide a current written job description, a letter of support from his/her employer, two professional references; and
- Complete an essay that demonstrates their commitment to young children.

What does the Early Care and Education Community Specialist Scholarship Program provide to someone enrolling in coursework in an early childhood associate degree program?

The program will provide an educational stipend of \$350 per each course taken annually to participants who are enrolled in early childhood associate degree coursework.

What does the Early Care and Education Community Specialist Scholarship Program provide to someone enrolling in coursework in an approved child development program at the bachelor degree level?

The program will provide an educational stipend of \$625 per course annually to participants who are enrolled in child development coursework within a bachelor's degree program at a participating university.

What does the Early Care and Education Community Specialist Scholarship Program provide to someone who already has a bachelor's degree (non early care and education degreed), and is taking early care and education core course work at the bachelor's level?

The program will provide an educational stipend of \$625 per course in core early care and education courses, or other related coursework, to participants who are enrolled in child development coursework within the graduate level at a participating university.

What does the Early Care and Education Community Specialist Scholarship Program provide to someone who already has a bachelor's degree in any field, and is taking early care and education core course work at the graduate level?

The program will provide an educational stipend of \$900 per course in core early care and education courses, or other related coursework, to participants who are enrolled in child development coursework at the graduate level at a participating university.

What type of compensation will someone receive when they complete their course work?

The program will provide a \$100 bonus for each course completed in an early childhood associate degree program, and \$150 for each course at an approved child development program at the bachelor's level and \$175 at the graduate level.

What is the responsibility of the scholarship recipient?

The scholarship recipient must

- Successfully complete semester hours towards an associate degree, bachelor degree or graduate level coursework as specified in the contract.
- Maintain at least a 3.0 overall G.P.A. each semester they receive the stipend.
- Apply for Early Educator Certification within 6 months of the award of scholarship or submit documentation of current level of certification.
- Continue employment with organizational employer while enrolled in coursework.
- Repay Child Care Services Association the entire amount of their stipend with interest if they fail to meet the work requirement.

What is the responsibility of the employer?

- Provide a written plan on how paid release time (not reimbursable) will be administered to the recipient during work hours if needed.
- Provide a statement of understanding that salary/wages will not be reduced as a result of participating on scholarship.

What colleges/universities participate with the Early Care and Education Community Specialist Program?

- At the associate degree level, participants can enroll at any of North Carolina's Community Colleges that offer an Associate Degree in Early Childhood Education program
- At the bachelor's degree and graduate levels, participants can enroll at any of the following universities. Some universities may only be offering B-K licensure programs at the graduate level. Admissions requirements and course delivery formats may vary by universities offering graduate level coursework.
