

T.E.A.C.H. Early Childhood® North Carolina Early Childhood Certificate Scholarship Program (with Employer Sponsorship)



What is the T.E.A.C.H. Early Childhood® Scholarship Program?

The T.E.A.C.H. Early Childhood® (Teacher Education and Compensation Helps) Scholarship Program was developed to upgrade the level of education of teachers working with young children while making the educational process affordable, increasing wages and reducing turnover.

What is the Early Childhood (Infant Toddler and Preschool) Certificate Scholarship Program?

This scholarship program offers scholarship funds to take courses at any of North Carolina's Community Colleges that offer an Associate Degree in Early Childhood Education program. It is a partnership between the child care provider, sponsoring center, and T.E.A.C.H. Early Childhood® North Carolina that enables providers to improve their skills, receive a financial reward and continue the availability of quality child care in local communities. Scholarships are available for family home providers, child care center teachers, and child care center directors. Scholarships are awarded on the basis of need and commitment to the Early Childhood Education field, as shown through information on the application.

Who is eligible for a scholarship?

- Any teacher, director, or home provider who would like to enroll in coursework toward an Early Childhood Certificate at a community college and who is employed full-time (30 hours/week minimum) in a licensed child care facility is eligible to apply for a scholarship.
- Individuals who have already completed EDU 119

What child care facilities can be a sponsoring center for a T.E.A.C.H. scholarship?

Licensed profit, church, not-for-profit, public, Head Start, GS-110 program, or family child care home wishing to make a commitment to teacher and/or director education and compensation by meeting the terms of the scholarship contract can participate.
